## V. Campus Review Items

A. Access to Student Data

Pg. 5-12

This new campus policy applies to all UC Merced employees and others using and disposing of university resources. The policy describes the conditions, and establishes procedures, under which student data may be distributed by Institutional Research and Decision Support (IRDS) and the Office of the Registrar.

#### B. Revised Honors Task Force Report

The Task Force on University Honors was originally established by Provost/EVC Peterson in December 2014, in light of anticipated enrollment growth at UCM. The revised report responds to recommendations made by Divisional Council as well as comments received from Senate committees. (CAPRA endorsed the proposal in fall 2015.)

# A. Revisions to G-28 Travel Regulations

Pg.153-165

The revisions to this Presidential policy are intended to make systemwide policy more "family friendly," by allowing reimbursement, in limited circumstances, for travel (including childcare) expenses for spouses, domestic partners, dependent-care providers, and dependents of employees traveling on University business and candidates for employment at the University of California traveling to UC locations for recruitment purposes.

B. Revisions to Senate Regulation 630 D **Pg.166-168**The revisions, which were put forward by the University Committee on Educational Policy, recognize the Natural Reserve System California Ecology and Conservation course as a systemwide course that can satisfy UC's senior residence requirement along with the Education Abroad Program, UC Washington, D.C., Program, and the UC Center in Sacramento Program.
