## IV. Membership in Graduate Programs (10 min)

Background: Graduate groups may have several levels of membership, for example, core and affiliate membership. Different UCM graduate groups have different policies for affiliates and various expectations. What are the rights of affiliates? What should they be from a campus-wide perspective? What is allowed under UC systemwide policy? What UCM policy pertains? For example: Can a non-faculty member (e.g., research associate) serve as sole principle advisor of a doctoral student, and/or of a M.S. student (i.e., without a ranked faculty co-advisor)? Can a non-ladder rank faculty member (e.g., adjunct faculty) serve as sole principle advisor of a doctoral or a M.S. student? What are the obligations of the affiliate to the program, and how does this impact their obligations to their core group? How are member's contributions decided, implemented, tracked, and evaluated? An example policy for memberships from Davis is appended.

**Action requested:** Discuss. Adopt for future deliberation and policy-making?

### V. Graduate Professional Development Course (10 min)

Background: Following the April 5 Graduate Council meeting, graduate groups were informed that GC preferred a set of cross-listed professional development courses and they were invited to participate. The graduate groups would submit CRFs (which could be bundled), including identification of the graduate group's PLO(s) that are relevant to the course. Otherwise the CRF submissions would be identical across programs. They would be coordinated under a common number and course name across programs. This was discussed at the April 26 meeting of graduate group chairs including the alternative of a separate course proposed by Graduate Division. Following discussion, the chairs moved that "Graduate Division offer a separate curriculum not affiliated with units/programs." This was supported 9 in favor, 0 opposed, 1 abstention (from a chair who walked in during voting). We propose that the campus overarching graduate PLOs be used for this course (see Appendix III (last page) of
