Graduate Division hired a higher education research and consulting firm to assist the campus in identifying ways to enhance graduate recruitment at UC Merced. The research conducted by Stamats included campus visitations, focus groups and image/perception surveys.

- **Systemwide Initiative: UC Conference on Doctoral Student Support**

A Steering Committee Co-chaired by Systemwide Provost Aimee Dorr and Senate Vice Chair Mary Gilly have organized a one-day all UC conference on Doctoral Student Support at UC Irvine. They are looking for two outcomes: a set of best practices and recommendations, with approximate price tags, for enhancing UC's success in recruiting and educating the best doctoral students. Towards that end, the Steering Committee has asked CCGA members to help structure the discussion through a formal request for proposals (RFP) process. The RFP should be a limited to one page per recommended action.

RFP should suggest proposed actions that could be taken to address the follow strategic issues:

1. Competitiveness in recruiting the best doctoral students
2. How the NRST is handled on the campuses (with respect to research grants and more generally)
3. Increasing the viability of academic departments to recruit international students when the record and pool makes that desirable; and
4. Enhancing professional development and career pathways for Ph.D. students.
