# Questions

- What criteria should be used to determine allocation? CAPRA's current guiding principles are designed to evaluate particular requests, not end state numbers.
  - FTE to major ratio, FTE to graduate student ratio? FTE to total enrollment?
  - What constitutes "sustainability"?
  - How do we account for disciplinary expectations/coherence?
  - How do we ensure research excellence?
  - What is the expected contribution to GE?
- What proportion of lines should be kept open for Targets of Excellence, spousal hires, and changes in enrollment patterns?

# CAPRA CRITERIA (for individual lines)

- Potential to strengthen research programs in existing or nascent programs/groups.
- Support of undergraduate majors and undergraduate teaching needs. These needs may be practical (student demand) or intellectual (or both).
- Support of graduate education through student mentorship and graduate teaching.
- Ability to build connections with existing or proposed organized research units or academic units.
