# III. American Anthropological Association (AAA) Resolution (10:30) Pg. 14-25

Guest: Professor Robin DeLugan, SSHA

In spring 2016, the AAA membership discussed whether to endorse a boycott of Israeli academic institutions. With no consultation with faculty, UC President Napolitano submitted a letter to the AAA, signed by the 10 Chancellors, on behalf of the campuses, condoning this action. Faculty members in the AAA and across the 10 campuses view this as unwarranted interference into the democratic process of the AAA, as well as a violation of academic freedom. They also object to the President's and Chancellors' assumptions that their view represents that of the UC faculty.

The formal response letter from UC Riverside faculty to Chancellor Wilcox is appended to this packet. Other UC faculty letters to their Chancellors are posted here.

### IV. Campus Safety (10:45)

AB 1872 (Gray) would appropriate \$1,315,000.00 from the General Fund to the Regents of the University of California, for allocation to UC Merced, for various public safety purposes. However, none of these purposes apply to classroom safety.

UCM still does not have a campuswide safety policy.
