INTERPRETATION OF SENATE BYLAW II.III.2.A

In response to a request from the Committee on Committees, CRE issued the ruling described below. The UCM Bylaw referenced above states that the membership of the Committee on Academic Personnel (CAP) consists of full professors ("[...] Members will be full professors." The Bylaw does not explicitly state that full Teaching Professors are not eligible to serve on CAP. CRE interprets "full professors" as including "full Teaching Professors". Without explicit Bylaw language regarding the membership of CAP, it is implicit that full Teaching Professors should be eligible to serve on CAP.
