On November 8, members of the Divisional Council (DivCo) unanimously endorsed a proposal from the Committee on Faculty Welfare and Academic Freedom (FWAF) to split FWAF into two stand-alone committees:

- The Committee on Faculty Welfare and

- The Committee on Academic Freedom
The rationale for this proposal is outlined in FWAF's [November 1 memo](#).

On April 4, 2025, members of FWAF unanimously approved the proposed amendments to the current FWAF Bylaws to reflect the formal establishment of a distinct Committee on Faculty Welfare (CFW). In a parallel action, FWAF also unanimously approved the adoption of newly proposed Bylaws for the creation of a separate Committee on Academic Freedom (CAF). Since the addition of a student representative is being considered for the CAF, this change automatically resulted in the need to expand Sections II.III. and II.IV of the Divisional Bylaws. Amendments were approved by the Committee on Rules and Elections (CRE) on April 22, 2025, and [DivCo on Monday, April 28, 2025](#).
