I. Chair's Report – Holley Moyes – 10:30am – 10:40am

A. November 8 and 18 Regular Check-in Meeting with GC Chair Scheibner, VPDUE Frey, and VPDGE Hratchian

Further discussions were held regarding the strike and final grading. Senate Chair LiWang and the Provost also plan to circulate a message to address concerns associated with the students marching in the halls, which is disrupting classes.

- B. November 15 Divisional Council Meeting
 - Chair of the Faculty Advisory Committee on Sustainability (FACS) Mike Dawson summarized the proposal to establish a Sustainability Work Group (SWG) to facilitate the development of an updated campus 2030 Sustainability Strategic Plan. FACS also plans to transmit a memo to Vice Chancellor for Research (VCR) Wilson regarding the climate funding.
 - The deadline to submit letters of intent for Senate grants is December 15, 2022, and the grant must be submitted by January 2023. The specific date in January has not yet been identified.
 - Professor Paul Maglio is scheduled to deliver a talk called "Designing the Management School of the Future" at 9:30am on Thursday, December 1, 2022.

Enrollment targets and new majors

AVC Orcutt reported that UC Merced's enrollment target for Fall 2023 is a minimum of 9,400 students - 8,625 undergraduate and 775 graduate. The institution has set a goal of 15,000 students by 2030. Other than aggressive enrollment recruitment, the Office of Admissions has implemented several strategic initiatives to reach this goal.

Institutional Research & Reporting Manager Gary Lowe reported on data from the Institutional Research & Decision Support (IRDS) website regarding areas that could assist in enrollment growth at UC Merced. His team gathered data from other UC research campuses with similar enrollment numbers and limited majors and created a list of majors that UC Merced does not currently offer. Several dashboards were created revealing this information, which is available on the IRDS website <u>here</u>, and a brief is available <u>here</u>.

A member inquired about data relative to transfer students. AVC Orcutt reported that UC Merced does not have pathways for some of Merced Community College's largest degree programs, which results in many students choosing to attend another university. This also affects the referral pool. The referral pool is a group of students who have applied to the University of California and have met the UC eligibility requirements but were not offered admissions at any of the UCs they applied to. The Office of Admissions contacts these students with an offer to apply to UC Merced. Many students have declined UC Merced's offer because of the limited major offerings, such as Criminology and Business Administration Accounting. Director Noji and AVC Orcutt also noted the importance of major and emphasis naming to easily identify the track they are interested in pursuing.

V. Update on Summer Online – Ryan Baxter, Heather Bortfeld, Alejandro Gutierrez, and Holley Moyes – 11:20am – 11:30am

On October 27, 2022, members Bortfeld and Baxter, Chair Moyes, Director of Summer Session Johnson, Registrar Webb, and VPDUE Frey met to discuss the approval of courses with online modality for Summer 2024. Today, participants will provide a summary of the discussion.

He also noted that the current list of prerequisites would be difficult for non-engineering students to fulfill. Lastly, he recommended adding MATH 131 to the list of technical electives.
