**Requested Action:** Catalog Subcommittee provides its recommendations on the AY 23 – 24 Catalog Updates. UGC approves the Catalog Updates and notifies the Registrar by May 1, 2023.

The lead reviewer for the SNS Catalog agreed with the proposed revisions and recommended approval.

The lead reviewer for the SoE Catalog noted that the Electrical Engineering (EE) major did not include a list of transfer requirements while all other Engineering majors did. The SoE Curriculum Manager clarified that transfer students will not be accepted until Fall 2025 for the EE major, and therefore, the transfer requirements have not yet been established.

The lead reviewer for the SSHA Catalog noted their concern regarding Public Health requiring their own version of a statistics course. Vice Chancellor for Student Affairs (VCSA) Nies noted that requiring a specific statistics course for a major/minor creates a barrier for transfer students because the course is often not available at community colleges. The SSHA Curriculum Manager clarified that the SSHA Course Articulation Analyst has worked closely with the Admissions Office and the Public Health faculty to ensure the statistics course is more accessible. A member noted the importance of encouraging the proposers to articulate the new course with other courses across campus that may be equivalent.

Lastly, a member recommended edits to the language in the GE Catalog, to which Registrar Webb confirmed that she can implement without the GEEC's approval.

**Requested Action:** Members discuss the proposal and lead reviewers' assessment, along with the SoE B.A. in Data Science and Analytics proposal and associated comments. Voting Members to vote in executive session to endorse the proposal if there is consensus.

The lead reviewers summarized their assessment noting their strong support for the proposal. They were particularly pleased with the removal of calculus as a requirement for the minor and that the proposers have included a strong pathway for transfer students. Although there is not an equivalent to Data Science 008 at California Community Colleges, proposers have noted that this is being addressed systemwide. The proposed major would also use existing resources; however, the lead reviewers questioned whether new faculty lines will be needed. The lead reviewers also recommended the proposers for both Data Science proposals collaborate on the naming and switching between the two majors.

**Requested Action:** Members discuss the proposal and lead reviewer's assessment. Voting Members to vote in executive session to endorse the proposal if there is consensus.

Members shared concerns regarding the naming of both Data Science proposals, and believed that naming all Data Science proposals, “Data Science and blank”, will create confusion for incoming students who are choosing a major from a drop-down list. VPDUE Frey also pointed out that students register for their first classes before being assigned an advisor, and therefore, are not given guidance on the distinction between the two majors when first registering.

UGC voting members agreed to approve both Data Science proposals with the recommendation that the proposers of both proposals collaborate on the naming of the programs.

**Requested Action:** Members discuss the proposal and lead reviewer's assessment. Voting Members to vote in executive session to endorse the proposal if there is consensus.

Member Petersen summarized his assessment highlighting the following concerns:

- The proposal notes that SPARK seminars count for any of the lower division requirements, which is unclear given the few required courses. The proposers should also be aware that double counting of SPARK for other program requirements is not allowed.
- No new faculty are required to deliver the program.
- The substitution criteria for the introductory course are broad.
- Primary instructors are included in the 5-year teaching plan; however, there is no mention of backup instructors.

UGC voting members agreed to approve the proposal with several non-substantial recommendations, as to not delay the implementation of the program.

Chair Bortfeld summarized her assessment of the proposal highlighting her main concern regarding the mention of emphasis tracks. The proposal links the Public Health major to medical and other health professional schools by outlining in the curriculum the “elective requirements for those seeking Pre-Med emphasis”. UGC found this confusing, as “emphasis” is a term for another type of undergraduate program. UGC voting members approved the proposal with the strong recommendation to remove this language.

Member Blanchette summarized his assessment and inquired about a definition for an Honors program. He noted that it was difficult to review the proposed program without a definition of what an Honors program is; however, the proposed program seemed to closely align with other Honors programs on campus.

Member Blanchette also noted his concern regarding the requirement of a preparatory course prior to the year the student would complete their senior thesis. However, the course is called senior thesis and is restricted to senior students. The SSHA Curriculum Manager confirmed that the proposers have already changed the title of the course to

“Cognitive Science Thesis” and have changed the prerequisite to make the course available to juniors.

With this point clarified, UGC voting members approved the proposal.
