## II. Chair's Report – Chair Eaton – 1:05pm – 1:15pm

A. February 2 BOARS Meeting

Academic Council Chair James Steintrager reported that the Area H review item has been circulated for systemwide review. The Academic Council voted to move this forward 13 to 6, with the BOARS Chair voting against. The Merced Division will be asked to provide comments, and AFAC is a lead reviewer. Controversy surrounds the issue of access and whether high schools could deliver the curriculum that is required by state law.

- **B.** February 12 DivCo Meeting
  - Senate Chair Hibbing reported on the MacKenzie Scott Gift Funds noting that the funds have been spent or committed and there will not be an endowment.

- Senate Chair Hibbing provided a detailed report on Area H. The Academic Council voted in favor of sending the Area H issue back to the campuses to discuss the access component. Ultimately, the issue will return to BOARS.
- Senate Vice Chair Mitchell provided an update on the two TAS working groups. The goal for both groups is to generate a fiscally sustainable TAS budget model that enables the achievement of the campus's student success goals.
- Chair Eaton and Professor Khatri reported on the Financial Management and Reporting Task Force noting the main focus is ensuring summer salaries are paid correctly.
- Discussions were held regarding delays on graduate students' and postdocs' research and time to degree. A survey was conducted to identify the impacts, and a memo with recommendations was transmitted to the administration.

## III. Proposed Amendment to AFAC Bylaws – Chair Eaton – 1:15pm – 1:25pm During the October 19, 2023 AFAC meeting, members proposed amendments to the

During the October 19, 2023 AFAC meeting, members proposed amendments to the AFAC Bylaws to include in the committee's membership a student representative appointed by the Graduate Student Association (GSA) as well as clarification of the voting rights of the student representatives and to remove redundancies. On December 4, 2023, CRE transmitted a memo to Chair Eaton, available <u>here</u>, recommending additional revisions.

Chair Eaton summarized CRE's recommended amendments, which aim to clarify the role of the student representative on AFAC. Members did not have any concerns.

### IV. Campus Review Items – All – 1:25pm – 1:55pm

A. Data Science and Policy Analysis Minor Proposal

The proposal was distributed to all Senate Committees and the SoE and SNS School Executive Committees.

Lead Reviewer: Joel Spencer

Member Spencer summarized his assessment noting that the new minor would be available to Political Science majors and non-majors. The minor will provide students with new tools and skills who seek occupations in public and private organizations that require data handling skills and social science study design. The minor would require a total of 20 units and appears accessible to students. Member Spencer shared only one concern related to data ethics and recommended the proposers provide a clear plan for how data ethics will be taught in the proposed courses.

- B. <u>Psychology B.S. Degree Program & Amendments to B.A. Degree Program</u>

Member Cleary summarized his assessment noting that the amendments to the B.A. is straightforward. The first amendment is a change in the Program Learning Outcomes (PLOs) to align with the most up-to-date American Psychology Association guidance for PLOs. The same PLOs are included in the B.S. proposal. The other amendment to the B.A. is modifying two existing writing courses, one upper division and one lower division, to add discussion sections to fulfill their writing requirements.

Member Cleary believes the rationale for the new B.S. program proposal to be strong. A student survey of current Psychology majors a UC Merced was conducted and is included in the proposal, which clearly demonstrates interest in the B.S. major and will be popular for pre-med students. The new major also requests two new hires that will replace existing lines.

Since the new major will be a popular choice to students interested in medical school, there is concern with the elective courses. There are several courses required for pre-med, and member Cleary recommended asking the proposers to provide a sample plan for how a pre-med student could complete the B.S. in Psychology and the additional pre-med requirements in Biology, Chemistry and Physics within four years.

- VI. Update to Biological Sciences (BIO) B.A. and B.S. Transfer Selection Criteria 2:10pm 2:25pm

Biological Sciences Department Chair Justin Yeakel submitted a memo to AFAC outlining changes to the selection criteria and transfer requirements for the Biological

Chair Eaton summarized the Biology Department's requests noting that the change to the B.A. criteria is to remove General Education requirements as major selection because most students complete IGETC (which will be transitioning to CAL-GETC). The change to the B.A. criteria is removing Organic Chemistry as a requirement for transfer.

Members did not have any concerns. The Admissions Office had previously spoken with Natural Sciences faculty and did not have any concerns.

A member inquired about Fall 2024 admission acceptances. Director Noji reported that UC Merced is up by 8% for first-year level applications and up by approximately 48% for non-resident international. UC Merced expects a record number of first-year applications this year; however, there is a slight drop in transfer applications. Decisions for first-year students will be made by March 1, 2024 and decisions for transfers will be made by March 15, 2024.

Director Noji also inquired about inviting the new Interim Vice Chancellor for Enrollment Management to future AFAC meetings, to which AFAC members agreed.
