V. Campus Review Items

- A. <u>Revised Proposal for a Minor in Management Analytics and Decision-making</u> (MAD) Proposal authors have revised the proposal to address Senate committee comments from AY 16-17. CAPRA is invited to review the revised proposal to determine if the revisions address the <u>committee's comments</u> from AY 16-17.
 Action: CAPRA to review the revised proposal and send a memo to the Senate Chair by 5:00 pm on Thursday, February 8.
- B. At the January 11 meeting, CAPRA members began to discuss the proposed revisions to Section Part II, Section 4 of the Division Regulations addressing Honors. The proposed revisions establish standards for awarding High and Highest Honors in the major. These revisions are requested by Divisional Council, following its April 24, 2017 endorsement of UGC's approval of *The Proposal for an English Honors Program*. At that time, Divisional Council noted that the Honors Program can be established, and students enrolled to graduate with honors, but that the program's desire to award High Honors and Highest Honors requires revisions to the Division's Regulations. There is no lead reviewer among Senate committees.

VI. Systemwide Review Items

- A. At the January 11 meeting, CAPRA members began to discuss the <u>Proposed Presidential</u> <u>Policy on Open Access for Theses and Dissertations.</u> Under such a policy, the UC would obtain a limited license to permit electronic theses or dissertations authored by UC graduate students to be available in an open access repository. COR, LASC, and GC are lead reviewers. **Action:** CAPRA to finalize its comments and send a memo to the Senate Chair by 5:00 pm on Tuesday, January 30.
- B. At the January 11 meeting, CAPRA members began to discuss the <u>Second systemwide review</u> of the proposed, revised APM sections: 285, 210-3, 133, 740, 135 and 235 pertaining to the re-designation of the L(P)SOE series. CAP is the lead reviewer.
