#### VI. Systemwide Review Items

A. Proposed revisions to APM 230 – Visiting Professional Researchers and Visiting Project Scientists The proposed revisions reflect changes made to comply with a stipulated agreement between the University of California and the International Union, United Automobile, Aerospace and Agricultural Implement Workers of America (UAW) in recognition of the Researchers-Academic Unit formation. On March 22, 2019, the UC and the UAW entered into an agreement to recognize the Academic Researchers United/UAW as the exclusive representative of a unit of employees as defined in the Stipulation. Pursuant to the stipulation, who qualifies as a Visitor in terms of the in-unit titles in the RA Unit has changed.

## B. Revised Presidential Policy on Native American Cultural Affiliation and Repatriation

On August 24, 2018, President Napolitano requested the convening of a workgroup to substantively revise the existing Policy and Procedures on Curation and Repatriation of Human Remains and Cultural Items. The policy pertains to the treatment and repatriation of Native American and Native Hawaiian human remains and cultural items under the University's stewardship and the University's compliance with the federal Native American Graves Protection and Repatriation Act.

The most significant revisions to the existing policy are listed in a systemwide cover letter here.

#### C. Proposed Revised Presidential Policy on Copyright Ownership

The current University of California Policy on Copyright Ownership, the principal policy governing ownership of copyrights at UC, has not been updated since 1992.
