Committee on Research (CoR) Minutes of Meeting March 15, 2023

Pursuant to call, the Committee on Research met at 1:30 pm on March 15 via Zoom. Chair Jason Sexton presiding.

- I. Chair's Report Jay Sexton
 - A. Divisional Council meeting March 6
 - CAPRA Chair Mitchell presented CAPRA's draft proposal for strike compensation for faculty. Divisional Council members had various suggested edits. The final proposal will be submitted to the EVC/Provost for his consideration.
 - Divisional Council approved CAPRA's report on the survey it conducted of department chairs in fall 2022 on staffing.
 - B. UCORP meeting March 13

CoR Chair Sexton reported that much of the discussion pertained to the implications of the strike. (VCR Wilson reminded CoR that she and VPDGE Hratchian were tasked by the Chancellor and EVC/Provost to assemble a work group to assess the impact of the strike on graduate education. VCR Wilson added that the work group will also take into account the impact on undergraduate research and faculty research.)

A CoR member stated that EVC/Provost Camfield attended a recent graduate group meeting and discussed UC Merced's goal of attaining R1 status and whether Carnegie classification criteria will change given that many universities will now admit fewer graduate students.

The updated Centers policy will need to be transmitted to Divisional Council for review before the end of spring semester 2023.
