At the March 30 meeting, FWAF members discussed Chair Jennings' talking points (available here) on one of the main concerns conveyed to him and other FWAF members in their office hours with faculty members and visits to department meetings. FWAF members also reviewed the FAQ document drafted by CAP in conjunction with the VPAP and APO (available here).

FWAF members agreed that 1) systemwide information and guidance on the impacts of the pandemic on faculty advancement and promotion should be more widely shared; 2) faculty need guidance on how to articulate their personal challenges in their self-statements and if they choose not to include such information, then review committees and department chairs should be made aware of the challenges through a different mechanism; and 3) the FWAF chair should elicit input from department chairs on what information they need to better advise review committees and faculty under review.

FWAF also discussed 1) the possibility of developing an Achievement Relevant to Opportunity (ARO) template that accompanies faculty members' self-statements in their personnel case files and 2) the need for additional guidance from UCOP and APO and ways to improve the dissemination of information to the faculty.
