# V. Campus Review Items

A. Interim Policy for Enrollment Management of Impacted Programs—Shawn Newsam, Alex Theodoridis

VII. Inquiry from MBSE about revising PLOs and its impact on CRF Process –Chair Westerling

MBSE's revised P&P (submitted on January 15, 2020) has an additional PLO (PLO 6), to which some courses being proposed for Fall 2020 are linked. MBSE is asking if the syllabi accompanying the CRFs should list PLO 6 or not.

### VIII. Discussion Item: CatCourses Auto-Populate Contents—Chair Westerling

Following GC's proposal, the CatCourses Work Group has consulted with administrative units on contents that will be auto-populated in CatCourses, which are available in <a href="the-draft policy document">the draft policy document</a>.
