Course Proposal (CP) Deadlines	Monday, October 14, 2024	<p>Last day for all course proposals (new and revised) in Curriculog to reach the Registrar for inclusion in the Fall 2025 course schedule (offerings). The Graduate Group Chairs must ensure that the CP clears the Assessment step and is ready to be forwarded by the Registrar to Graduate Council on or before the deadline. Before submission to the Senate Office, the CP should reflect all needed corrections and clarifications from School and Registrar reviews.</p> <p>Curriculog is available here: https://ucmerced.curriculog.com/</p> <p>Last day to submit substantial revisions to existing academic programs for implementation in Fall 2025. Proposals must include approval memos from the relevant School leads (Dean, Curriculum or Executive Committees, and Department Chairs) and a list of the proposed changes.</p>
	Monday, February 3, 2025	<p>Last day to submit all Course Proposals (new and revised) to the Registrar on Curriculog for inclusion in the Spring 2026 and Summer 2026 course schedules.</p> <p>Last day to submit proposals to GC for new programs or major revisions to existing academic programs for implementation in Fall 2026. <u>Proposals must include a draft Catalog copy.</u></p>
Other Internal Deadlines	October 31, 2024	<p>Concentrations and/ or Designated Emphases: Last day to submit proposals for Concentrations and/or Designated Emphases to <i>Graduate Council</i> for review and possible approval for Fall 2025. Proposals will be accepted after this date but approval cannot be guaranteed for Fall implementation. The related policy is here and associated summary form here.</p>
	January 3, 2025	<p>Catalog: Graduate Groups submit to <i>Graduate Division</i> revisions to the AY 25 - 26 UC Merced Catalog.</p>
	January 21, 2025 First day of spring instruction	<p>Bylaws: Last day to submit revised Bylaws to <i>Graduate Council</i> for internal review and approval for Fall 2025. The related policy is available here and the template here.</p>
