Course Proposal (CP) Deadlines	Monday, October 13, 2025	<p>Last day for all course proposals (new and revised) in Curriculog to reach the Registrar for inclusion in the <b>Fall 2026</b> course schedule (offerings). The Graduate Group Chairs must ensure that the CP clears the Assessment step and is ready to be forwarded by the Registrar to Graduate Council on or before the deadline. Before submission to the Senate Office, the CP should reflect all needed corrections and clarifications from School and Registrar reviews.</p> <p>Curriculog is available here: <a href="https://ucmerced.curriculog.com/">https://ucmerced.curriculog.com/</a></p> <p>Last day to submit substantial revisions to existing academic programs for implementation in <b>Fall 2026</b>. 	Monday, February 2, 2026	<p>Last day to submit all Course Proposals (new and revised) to the Registrar on Curriculog for inclusion in the <b>Spring 2027 and Summer 2027</b> course schedules.</p> <p>Last day to submit proposals to GC for new programs or major revisions to existing academic programs for implementation in <b>Fall 2027</b>. <u>Proposals must include a draft Catalog copy.</u></p>
Other Internal Deadlines	October 31, 2025	<p><b>Concentrations and/ or Designated Emphases:</b> Last day to submit proposals for Concentrations and/or Designated Emphases to <i>Graduate Council</i> for review and possible approval for Fall 2026.
