**GC ADMINISTRATIVE ORGANIZATION**

GC operated with three standing subcommittees that met primarily via email throughout the year. The CRF Subcommittee reviewed all requests for new graduate courses and modifications to existing courses, with its recommendations presented to the Council as a whole. The CRF Subcommittee also made suggestions for further improvements in the course review process through Curriculog (Online Course Proposal Review Policy).

Likewise, the Policy Subcommittee made recommendations to the Council as a whole regarding all graduate-related policies, including Graduate Group Policies and Procedures, Graduate Group Bylaws, and Graduate Group catalog entries.

The Fellowship Subcommittee led GC's oversight of graduate fellowships and awards. The Subcommittee made recommendations to the Graduate Division on consolidation of smaller fellowships, and suggested modifications to the review process aimed at ensuring consistency of the reviews across applications.

## **GRADUATE STUDENT APPOINTMENTS AS INSTRUCTOR FOR UPPER DIVISION COURSES**

GC considered, and approved jointly with UGC, 8 requests to appoint graduate students as instructors for upper division courses. Effective February 18, 2022, requests to appoint graduate students as instructors for upper division courses no longer require UGC's approval. GC approved a total of 24 petitions, as well as requests for 6 reappointments.
