LASC has worked towards this goal by visiting different Departments around campus and delivering a presentation specifically on the UC's transformative agreements. Chair Blois provided a recap of the Departments that LASC has successfully presented at. Chair Blois suggested a co-presentation model for new members that are not familiar with the nature of the presentations.

IV. Consent Calendar

A. Approval of today's agenda

Action: The Consent Calendar was approved as presented.

V. LASC Conflict of Interest Policy

Action: Members approved the draft policy. The draft policy has been sent to the Committee on Rules and Elections (CRE) and the Senate Chair for their consideration.

VI. UCOLASC Meeting Update – Member DePrano

A. Open Access (OA) Ambassador Program update

Member DePrano shared that an Open Access (OA) publishing decision tree, intended to help faculty navigate the complicated open access publishing environment, has been completed by a UC Office of Scholarly Communication (OSC) working group. The document consists of information on why one should publish through open access, the UC Open Access (OA) policies, key terms, and who to contact to address any questions.

Member DePrano noted that in 2022, UC Merced published 64.4% of its research through open access, while 35.6% was published in closed or behind a paywall. In 2023, the percentage of research published through open access rose to 78.6%, with 21.4% published closed or behind a paywall. A contributing factor to this increase was UC Merced's Open Access (OA) Ambassador Program. In 2023, UC Merced ranked among the top campuses for overall open access participation and demonstrated the most significant improvement, achieving a 14.2% reduction in opt-outs from 2022 to 2023. Member DePrano expressed gratitude to LASC members for their efforts in educating the campus community about open access publishing.

B. UCOLASC Meeting update from May 10, 2024

Member DePrano shared that a California Digital Library (CDL) initiative aimed at making data more accessible and shareable has resulted in a machine-actionable approach to data management and sharing. This project will improve compliance as data

sharing becomes increasingly required. Pilot programs at UC focus on use cases that enable institutions and researchers to engage with data management effectively. Member DePrano also shared updates on Project Library Expansion of Networked Delivery (LEND), that will investigate the potential for expanded lawful use of digitized books held by academic and research libraries.

VII. LASC Goals for AY 2024-2025 - All

Chair Blois presented the <u>AY 2024-2025 goals</u>, which include ongoing objectives that LASC has addressed in previous years. Members agreed to expand the second goal from "Promote Open Access (OA) Publishing" to "Promote Open Access (OA) Scholarship." Members agreed to continue to discuss and modify these goals.

Action: The <u>LASC Goals for AY 2024-2025</u> has been uploaded to LASC's Box folder. Members will continue the discussion of LASC's goals during the October 11 meeting.

VIII. Consultation with University Librarian – Haipeng Li

University Librarian Li will provide brief updates on the National Endowment for the Humanities (NEH) project and the Library service hours.

Due to the deficit in the Library's budget, the student salary budget has decreased, resulting in a reduction of the Library service hours by 20%. University Librarian Li shared that the Library has received complaints from students and faculty and is keeping record of this data.
