A. Revised UGC Bylaws - Chair Zanzucchi

Proposed UGC Bylaw revisions were approved by UGC on September 25, 2017 and sent to DivCo on September 27.

Action: Discuss Senate Chair's feedback and revise Bylaws as relevant.

B. Proposed revisions to Part II, Section 4 of the Division Regulations addressing Honors.

Background: In March 2017, during the review of the English Honors proposal, UGC approved the proposal with the caveat that CRE revise the corresponding Regulations (please see UGC's recommendation on page 7 of the PDF hyperlinked above in "Proposed revisions").

These revisions are requested by Divisional Council, following its April 24, 2017 endorsement of UGC's approval of the Proposal for an English Honors Program.

Proposed Honors Regulations Language (also hyperlinked above, on page 2):

D. Honors Programs

Each program offering an undergraduate major curriculum may establish an Honors Program including special courses, or supplementary and advanced directed study, or both. Such programs must be approved by the Undergraduate Council (UGC) and require at least: (a) a GPA of 3.5 in the major as a prerequisite; and (b) 8 units of special courses, or supplementary and advanced directed study, or both. Programs may include levels of honors at graduation.

Members of the Academic Senate who are members of the program or group in charge of each major are responsible for (a) defining the criteria and grade point average to be used in determining the level of honors to be awarded, (b) admitting students to their approved Honors Programs, and (c) for delivering special courses. Any change to the criteria for awarding levels of honors will require review and approval of the Undergraduate Council.

These revisions were approved by the Committee on Rules and Elections on October 11, 2017.

Action: UGC to approve the proposed Regulations and respond to the Senate Chair by 5:00pm on Tuesday, February 13, 2018
