### VI. Campus Review Items – 10 min

A. Proposal to Establish the working title of Teaching Professor for faculty in the LSOE Series – Angelo Kyrilov

Background:

In May 2018, in the context of revisions to <u>APM 285</u>, Academic Council <u>voted in favor of maintaining the existing titles in the Lecturer with Security of Employment series, while also allowing discretion for individual campuses to use the title of "Teaching Professor" as an alternative to "<u>LSOE</u>". The revisions went into effect October 1, 2018, and each campus is expected to implement them by July 1, 2019.</u>

### UNIVERSITY OF CALIFORNIA

<u>In their December 10, 2018, memo to VPF Matlock</u>, the Consortium on the Advancement of Teaching Professors requested that the title of Teaching Professor be formalized (in place of L(P)SOE).

VPF Matlock supported this request and <u>asked the Senate to discuss the adoption of the Teaching Professor working title</u>, specifically:

- Assistant Teaching Professor for those holding a LPSOE payroll title
- Associate Teaching Professor for those holding a LSOE payroll title
- Full Teaching Professor for those holding a Sr. LSOE payroll title

- B. <u>Proposal to change the name of the Social Sciences and Management (SSM) Academic (Bylaw 55)</u> <u>Unit to Economics and Business Management (EBM).</u> – UGC Reviewer TBD

The SSM unit seeks to change the program's name from "Social Sciences and Management" to "Economics and Business Management" to better reflect the content of the reorganized program's research and teaching.

# C. <u>Proposed revisions to Part IV. Section II: Master's Degree Requirements of the Merced Division</u> Regulations

UGC may opt not to opine as the Council has other pressing business and this proposal has little impact on undergraduate programs.

The proposal is to reduce the minimum number of units of approved courses required by a master's degree by comprehensive exam (Plan II) from 30 to 24 and commensurately, to reduce from 24 to 20 the number of units which must be from graduate-level courses in the 200 series. These changes seek to make Masters degrees at UC Merced commensurate to those offered at other UC campuses.

#### UNIVERSITY OF CALIFORNIA

The proposed revision to Senate Bylaw 336 focus on the Committee of Privilege and Tenure's handling of disciplinary cases. Specific changes include the process by which Sexual Harassment and Sexual Violence are reviewed.
