I. Meeting

II. Chair's Report

May 7 UCEP Meeting

Discussion was dominated by the Regulations, drafted by UCEP, which would govern systemwide online courses. A discussion followed on the need to address the Credit Hour Policy at the systemwide level.

Ralph Wolff, WASC President, and Teri Cannon, Executive Vice President discussed the proposed Handbook Revision.

V. Request from SSHA- Proposal to Revise the ECON Major

On April 30, UGC received a request from SSHA to revise the ECON Major, effective Fall 2012. The following curriculum changes have been proposed:

- Cancel cross-listing of ECON 100 (Intermediate Macroeconomics) and ECON 101 (Intermediate Macroeconomics).
- Change the program's Statistics requirement to require ECON 10 (rather than the choice between ECON 10, POLI 10, SOC 10, and PSY 10).
- Revise ECON 161 to be titled International Finance (from International Macroeconomics). This change would better reflect the content of this course, and the title would stress more exchange rate determination and risk management (topics of International Macroeconomics) making the course a natural component of the program's Finance and Strategy track.
- Revise title of ECON 141 to reflect actual title and content.

A motion was made, seconded and carried to approve the revised ECON Major proposal.

VI. Program Review of Minors

The Senate Office received a request from SSHA regarding the program review of standalone minors and whether the review of those minors should be combined with the review of different but related majors. For example, could the Spanish minor be wrapped into the program review of Literature and Cultures? Services Science into Management? Philosophy into Cognitive Science? Comments/Concerns:

- Should a threshold enrollment requirement exist for minors that undergo Program Review? In the absence of a clear enrollment requirement, UGC then agreed to defer response to SSHA until The Division Council discussed the enrollment requirements for Program Review.
- Should student target numbers be part of the Program objectives?
- If enrollment of a minor is high, should the minor be required to become a major?
- Policies need to be in place that require programs to establish a timeline for a program internal assessment.

Action: Chair Camfield will present the SSHA request at the next Division Council meeting.

V. Update on Academic Honesty Policy

The Division Council approved the charge for the Academic Honesty Task Force. Membership of the committee will consist of UGC members, Coordinator of Institutional Assessment, students, and staff. At the beginning of AY 2012-2013 UGC members will be solicited to serve on the committee.

VI. Report from VCSA Jane Lawrence

- Academic Calendar

The EVC has submitted to the Academic Senate the Academic Calendars up-to AY 2015-2016 for review. UCOP has asked that institutions with similar semester systems have the same Academic Calendar start dates. Summer session calendars have not been finalized and were not included.

Action: UGC will approve the Academic Calendar as a consent item.

- Updated Enrollment Data

The Administration is focused on managing student growth to 5,600 students. A total of 1,900 SIRs have been received. All new freshmen transcripts will be reviewed to make sure they are eligible for enrollment for Fall 2012. VC Lawrence will work with AVC Thompson and the Director of Admissions to provide a detailed analysis of enrollment at the end of the fall semester.
